

## "Restoration of the Taylor House at Hollywood Plantation, 2012-2019" Tommy Jameson

Tommy Jameson, a native Arkansan, graduated from the University of Arkansas in 1977. After becoming interested in historic architecture during his senior year of college, Tommy purchased his first historic home just after graduating. Since that time he and his wife have rehabilitated three more historic houses, including the firm's offices in a 1904 Colonial Revival cottage near the Arkansas State Capitol and the 1936 Werner Knoop House in Little Rock's Hillcrest neighborhood. He founded Jameson Architects P.A. in 1996, which focuses on the development of thoughtful, creative preservation solutions for the community, the workplace and the home. Tommy has worked on many of Arkansas' most visible historical properties, including the Rice-Upshaw House, the Old State House Museum, and many of the structures at the Historic Arkansas Museum. In 2017, Tommy was the recipient of the Parker Westbrook Award for lifetime achievement in historic preservation from Preserve Arkansas.

# Annual Report to Arkansas Association of College History Teachers September 8, 2019

NHD Arkansas had more than 9,000 students engaged in historical research in classrooms this past year, with more than 1,200 of those participating in their respective regional contests. All seven regional programs sent students to the state contest, held April 11, at UCA. Of the 353 students who competed at the state level, 61 advanced to the national contest, held in June at the University of Maryland.

Three Arkansas entries earned awards at the national contest. Conway students Ethan Marotte, Olivia Marotte, and Simon Marotte won First Place for their senior group performance, "This Was Our War": The Émigré Ritchie Boys' Contribution to an Intelligence Triumph in the Midst of Personal and Global Tragedy. Vondran Nolan, student at Har-Ber High School, Springdale, won Third Place in the senior individual exhibit category for his exhibit, "Helen Keller: From Tragedy to Worldwide Triumphs." London Blackwell, Alma High School student, won the Special Prize in Science and Technology for her senior individual documentary, "The Silence After the Fall: The Hidden Triumphs and Tragedies of the Manhattan Project."

The 2020 NHD theme is Breaking Barriers in History. As always, historians and humanities scholars play a critical role in the success of this important program by giving a few hours of a Saturday to judge at either the state contest (Saturday, April 12, 2020) or at one of our seven regional contests. Please join us and see what these young people know about history and historical research.

# BYLAWS OF THE ARKANSAS ASSOCIATION OF COLLEGE HISTORY TEACHERS

{adopted October 5, 1974} {revised October 3, 2008; September 30, 2010; October 6, 2011}

### **ARTICLE I**

Name

The name of this organization shall be The Arkansas Association of College History Teachers.

### **ARTICLE II**

Object

The object of this Association shall be to improve the teaching of History for all levels of instruction; to advance the professional interests of its membership; and to establish closer rapport among the various History faculties.

### **ARTICLE III**

#### Members

Section 1. Membership is open to all teachers or former teachers of History in two-year and fouryear colleges and universities in the State of Arkansas on payment of dues set by the organization.

Section 2. Associate membership is open to graduate students and secondary school teachers in History and Social Studies on payment of dues set by the organization. Associate members shall be entitled to all of the privileges except those of making motions, of voting, and of holding office.

# ARTICLE IV Officers

- Section 1. The officers of the Association shall be a President, a Vice-President, and a Secretary-Treasurer. These officers shall perform the duties prescribed by these Bylaws and by the parliamentary authority adopted by the Association.
- Section 2. The officers shall be elected by ballot to serve for two years, and their term of office shall begin at the close of the annual meeting at which they are elected.
- Section 3. No member shall hold more than one term in the same office except for the Secretary-Treasurer.

### ARTICLE V

### Meetings

Section 1. The Association will meet at least once a year for the purpose of electing officers, receiving reports of officers and committees, and for any other business that may arise.

Section 2. Special meetings can be called by the President or by the Executive Board.

### **ARTICLE VI**

### The Executive Board

Section 1. The officers of the Association and the immediate past president shall constitute the Executive Board.

Section 2. The Executive Board shall have general supervision of the affairs of the Association between its business meetings, fix the hour and place of meetings, make recommendations to the Association, and shall perform such other duties as are specified in these Bylaws. The Board shall be subject to the orders of the Association, and none of its acts shall conflict with action taken by the Association.

### **ARTICLE VII**

### Committees

Section 1. A Program Chair shall be appointed by the President, whose duty it shall be to plan the annual program of the Association.

Section 2. Such other committees, standing or special, shall be appointed by the President as the Association or the Executive Board shall from time to time deem necessary to carry on the work of the Association. The President shall be *ex officio* a member of all committees.

### **ARTICLE VIII**

### Parliamentary Authority

The rules contained in the current edition of *Robert's Rules of Order Newly Revised* shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with these Bylaws and any special rules of order the Association may adopt.

#### **ARTICLE IX**

### Amendment of Bylaws

These Bylaws can be amended at any regular meeting of the Association by a majority of those present and voting, provided that the amendment has been distributed to the members of the Association at least one month prior to the meeting at which it is to be voted on.
